

## *CSPB - A Confederation strong, independent and definitive*

Until 1950, the civil servers were represented by associations. It was from 1952 that the entities and movements representing the public servers understood the need to create a body of federal character, unifying and normalizing the struggles and demands. Six years later, was born the Confederation of Public Servers in Brazil - CSPB.

Since then, many were the battles and victories of the civil servers. These include the achievement of the first servers Status of Federal Government of Brazil, with Law No. 1.711/52, the first plan of positions, with Law No. 3780, the fight to ensure the right to organize, the right to collective bargaining and the right to strike the professional civilian government employee.

In the years the acquiescent Dictatorship, the CSPB paid for his role in the exile, imprisonment and even death of its main leaders, which led the contracting phase to an atypical relative to their history and almost informality and underground structures. In its congress has proposed and fought for the deployment of "Amnesty Broad, general and unrestricted."

During the National Constituent Assembly, the CSPB was the main stronghold of the category in the process of constitutional reform, the neoliberal inspiration. With the advent of the Citizen Constitution, the Confederation has become legally constituted to act in the protection of individual rights and collective category of Professional Public Worker Civic, the three levels and in all three spheres of power, are active, retirees and their pensioners.

The National Congress records in its annals CSPB in the performance of administrative reforms and welfare, that influence the outcome by changing the original projects of governments, infinitely more damaging that those who remained approved.

In recent years, has returned to an entity primer of struggles, assuming a task whose size and historical transcendence influenced decisively in the direction of the Brazilian trade union movement, continental and global.

Today, after completing 50 years of struggles, many victories and some losses, it is an entity reinserted, with credibility, based on broad and solid, with financial independence and its own structure and sufficient to meet the demands of the servers.

This is the Confederation of civil servers in Brazil. Of the past, present and future. And so a new history of public servers is being written by CSPB.

# 1ST COMPETITION FOR MONOGRAPHS OF THE CSPB

## *"The Democratic and Social State of Law" and "The Public Server in the Social Construction of Power"*

As part of the celebrations of its 50th anniversary of foundation, the Confederation of Brazil's Public Servers holds the 1ST COMPETITION FOR MONOGRAPHS OF THE CSPB, open to society and the public servers of the Americas in order to reap its proposals to the board and the leaders of the federations and affiliated trade unions bound trace the profile of the Democratic and Social State of Law that we want; reap political propositions and define actions and strategies for the participation of the public service in the Social Construction of Power. The competition will be governed by rules to follow:

### **Of the subject, the object and goals**

The 1st Competition for Monographs of the CSPB has the themes "The Democratic and Social State of Law" and "The Public Server in the Social Construction of Power". Its object meets the determination of the 22nd National Congress of civil Server, held from 13 to December 16, 2007, in Porto Alegre (RS). Aims to stimulate the production of studies and research to enable the drafting of the proposal to be defended with society to guide the planning of strategies and actions of the CSPB. Its purpose, too, get closer to the Confederation's rating represented.

### **Of the participants**

The competition is divided into two categories: the first one with the theme "The Democratic and Social State of Law", open to society in general, in order to stimulate the production of theories that guide the CSPB and its affiliated entities and related activities in necessary to establish a model of democratic and social state of law we want; and the second, with the theme "The Public Server in the Social Construction of Power" is aimed at public servers of South America, Central and North, the three powers – Executive, Legislative and Judiciary, the three levels – federal, state and municipal – and is designed to meet the aspirations and proposals of the category, with a view to developing a list of priorities. Can not attend those members or relatives, until the second grade, the Award Committee.

### **Sign-up**

Entries will be accepted during the period of 05 September 2008 to 30 April 2009. each participant can compete individually, with only a monograph of 25 (twenty five) to 30 (thirty) pages, excluding annexes and references, typed in double space between lines, font size 12, Arial font, the left and above 3cm , Right and bottom of 2cm, on white paper, A4 (210mmx297mm), only on one side, within the rules of the Brazilian Association of Technical Standards - ABNT. The monograph should be sent on CD with five (5) identical copies printed, stapled and with pages numbered and initialed. The participant must attach a summary of two pages in the same format, which will inform the goals, the contribution of work and key findings. All material should be properly identified with the pseudonym of the participant and put in an envelope, along with the registration form, available on the website of the Confederation - [www.cspb.org.br / concursodemonografias](http://www.cspb.org.br/concursodemonografias). The work should be accompanied by a small autobiography. On the outside of the envelope, should bear the pseudonym of the participant and the title of the competition, specifying the category.

### **The place of entries**

The monograph can be delivered personally or sent by post, which must be registered letter or parcel delivery of the kind, until the day 30 April 2009, is considered the date of the protocol or the stamp of post full of material, to the following address: SCS Table 1, Bl. K No. 30, Ed. Denasa, 1st floor, CEP 70398-900, Brasilia - DF . Will not accept registration done by fax, mail and / or working manuscript. The inscription implies the full acceptance of the regulation, no candidate with the appeal later. It will be validated only those whose registration is completed the plug on a correct, complete and legible and accompanied by copies of personal documents (RG or CPF). The entry that does not meet the rules are disqualified by the commission prior review of compliance with the regulatory devices.

### **The characteristics**

The monograph will focus on the current situation and be applicable to public service channels. The text must be unpublished and written in Portuguese, Spanish or English and will be eliminated that has already been disclosed by any vehicle of communication, in whole or in part. The candidate is responsible for the authorship and content of work and is automatically excluded from the selection at any stage of the competition, with the appropriate punishment in cases of plagiarism. The act of registration implies the automatic assignment of copyright, reserving to the CSPB the right to publish and disseminate in their media and use of the proposals made in its activities. ### **The coordination**

It receives CSPB At the entries, check the documentation and the work directed; constitute Award Committee; forward the papers to members of the Judging Committee; disclose the outcome, rewarding the winners; resolve controversies and disputes or situations not in this regulation.

### **Commission Award**

The Award Committee will be composed of five (5) members, with 02 (two) directors of CSPB and 03 (three) guests, suitable and notorious know about the subject. Each member assign scores of 5 (five) to 10 (ten), each monograph will be winners and those who obtain the May number of points. The decision Award is sovereign and her not be appealed or challenged. By votes of the majority of its members, may decide to withhold the prize if none of monographs have satisfactory quality or is not appropriate to the subject. The members of the Judging Committee may be replaced at any time by other professionals also suitable. Depending on the number of subscribers, the CSPB could form a Commission judges for each category and state secretaries. The unclassified work will be made available for candidates to be removed within thirty (30) days from the dissemination of the results. After the expiry of this period, the work will be destroyed.

### **Dissemination of results**

The relationship with the names of four (4) ranked first – two in each of the categories – and blessed with honors - the third to fifth placed in each category – will be published on the website of CSPB, day 15 June 2009, without identifying the order of classified.

### **The prize**

Will be rewarded in cash to the authors of four (4) best monographs. In both categories the prizes will be R\$ 10 thousand (ten thousand reals) and R\$ 5 thousand (five thousand reals), respectively, for the first and second placed, free of incidence, deductions and withholding taxes. The four are entitled to classified airfares, round trip, and daily – unless live (in) or working (on) in the Federal District – to attend the ceremony commemorating the fiftieth anniversary day 27 June 2009. Those who classify the third to fifth places in each category will be invited and will receive honors.
